## Superintendent's Report

# Financial Update

Dr. Steggall reviewed August 2021 Balances. She stated that Fund 4 had a balance of \$492,503.01 and that Fund 1 had a balance of \$2,277,952.18. Dr Steggall stated that with the school year just starting, there were no financial concerns.

# Start of School Updates

Dr. Steggall stated that enrollment stands at 335 at Ellis, 138 at Middle School and 189 at the High School for a total of 662 students. She stated the the contractors were finished with the High School Roof with a final walkthrough next week. Also, the softball / baseball field had the final walkthrough today with a few things to finish up.

#### **COVID Update**

Dr. Steggall stated that numbers were on the website by building last week and that this week district numbers as a whole are posted for the student population. As of today, there is 1 student positive at Ellis and 1 at the High School, 1 staff member positive, 20 quarantined at Ellis and 6 quarantined at the Middle School. Dr. Steggall stated that the 20 at Ellis is mostly one classroom. Discussion took place regarding the county statistics as well as the school statistics. Dr. Steggall reviewed her discussion with Blair from the County Health Department. She reviewed the trend of the prior week numbers versus this current week's numbers which are down. Discussion took place among the Board regarding the topics of masking requirements, quarantine, vaccinations and various COVID scenarios. Discussion took place regarding the addition of a COVID masks review at each meeting. Dr. Steggall reviewed how contact tracing is handled within the schools.

## **Board Vacancy**

Mark Coulter reviewed the process the Board would go through. Each candidate for the board vacancy will have 5 minutes to speak.

Derek Treichel spoke regarding his desire to fill the vacant board position.on the board. The board asked questions of the candidate.

Cory Verdi not able to attend. Dr. Steggall stated all his info had been provided previously.

Nick Wade spoke regarding his desire to fill the vacant board position on the board. The board asked questions of the candidate.

ACTION III: David Dow moved to appoint Nick Wade for the vacant board position. Keith Carnie seconded the motion. (no vote taken at this time)

Discussion took place among the board members. Keith Carnie rescinded his second to the motion and David Dow then rescinded his motion.

## Insurance Renewal

Dr. Steggall stated that CBIZ had negotiated a 3.77% increase down to 0% increase on the district health insurance. She also stated that they negotiated a 22.4% increase down to 8.5% increase on dental. Life insurance rates remained the same through January 2024.

presented. Keith Carnie seconded the motion. Vote: 7-0.

## **HVAC Bids**

Dr. Steggal explained that the bid approved prior had not been bid correctly and that new bids would be coming next month.

#### New Board Policy C-165-A

Dr. Steggall stated that EdCounsel had a new policy regarding the recording of IEP or 504. She explained that per attorney recommendation, the district will record also and become part of the student file. Discussion took place regarding the policy.

Thiesen seconded the motion. Vote: 7-0.

## Memorandum - re: Building with the City of Plattsburg

Dr. Steggall reviewed a memo of understanding between the district and the city. She stated that if the estimates are outrageous we may not move forward with the building. If it makes financial sense, we will proceed and the city will then give the district the building within a year. Discussion took place regarding the memorandum with some recommended updates.
