Superintendent's Report

Financial Update

Dr. Steggall reviewed the August 2021 Balances. She reviewed the balances of Fund 1 and Fund 4. Dr. Steggall gave an update on ESSER 2 and 3 funds and some extra transportation funds the district would be receiving.

Facilities Update

Dr. Steggall stated that the roof projects were completed and that the parking lots are still to be finished. She stated that the district had hosted district softball last week and will be hosting district volleyball. Dr. Steggall reviewed the upgrading of classroom spaces with the extra funds each teacher has been given.

CSIP Update / MSIP 6

Dr. Steggall reviewed the goals, tools, and district scorecard. She also reviewed some MSIP 6 highlights. Dr. Steggall presented a video on how our education system has evolved over the past. She then reviewed the next steps of our district's plan. Discussion took place on new ways education could work.

ParentSquare - Community Option
