Superintendent's Report

Financial Update

Dr. Steggall reviewed revenue and expenses for the month of October 2021. She reviewed the balances of Fund 1. Dr. Steggall reviewed a spreadsheet of the CARES funding. She reviewed ESSER 2 and ESSER 3 funds that can be drawn down during this school year. She reviewed

various other grants and monies available.gave an update on ESSER 2 and 3 funds and some extra transportation funds the district would be receiving.

Revenue for Oct and Expenses and the balance of Fund 1.

SS reviewed a spreadsheet of the CARES Funding. She reviewed ESSER 2 and ESSER 3 funds that can be drawn down during this school year. She reviewed various other grants and monies available.

District Updates

Dr. Steggall reviewed the makeup of PD days and stated that personal growth for staff is in the afternoon of those days. She then stated that social and emotional needs from students are greater than in the past. Discussion took place regarding the increased needs of the students and possible ways to accommodate and support the need.

Dr. Steggall stated that there have been 6 new substitutes added in the last 2 months. She stated that at this time, no increase in the pay rate. Dr. Steggall stated that there have been several new students enrolled since October 15, 2021. Students include 2 at the high school, 7 at the middle school and 6 at Ellis with only 2 outgoing during that time.

Dr. Steggall gave an update on the test to stay that had been approved the prior month. She stated that 80 tests had been received for the test to stay program. Dr. Steggall stated that a part time person to help with Nurse Fish was being reviewed. She stated that there were only household positive cases at this point.
