Masonic Lodge Donation Presentation

JP Cradic explained the matching gift from the Masonic Lodge Foundation. He stated that last year's donation check was over \$16,000. Mr. Cradic stated that the monies are used to go directly for student needs. He, Curtis Cradic and Michael New presented Dr. Steggall with a check for \$29,835 for this year's donation. Dr. Steggall explained how the counselors in each building use the funds for students.

Superintendent's Report

Financial Report

Financial Report - Joe Kinder (Stifel)

Joe Kinder attended electronically. He reviewed where the district stands on bonds and assessed values. He reviewed options that the district has with debt service funds. Mr. Kinder stated that the district can make prepayments on the current debt. He stated that over the next 2 years, the district could save \$500,000 to \$550,000 in interest. He also stated that there is the opportunity to do additional no tax increase bond issues. He reviewed state bonding capacity and that possibly the district could run another \$7 million bond in a few years. Mr. Kinder reviewed when voters have to approve various items related to bonds and levies. Discussion took place regarding various options for the district.

Facilities Undate

Dr. Steggall stated that summer maintenance is moving along and Ellis is almost complete. She stated that outdoor projects will be started next. Dr. Steggall informed the board that the plaques at the track have been installed with a presentation at an upcoming football game.

MSBA Conference November 2-4

Dr. Steggall stated that the conference is November 2-4. Deadline for registering is mid October and in Kansas City for any member wishing to attend.

NEW BUSINESS

Food Service Price Increase 23/24

Dr. Steggall reviewed the increase in breakfast and lunch prices for 23/24. She stated that the recommendation is a 5 cent increase for meals. Adult meals will be \$2.20 for breakfast and \$3.70 for lunch. Dr. Steggall stated that there will be a tv and free lunch for a year drawing for everyone that fills out paperwork.

ACTION III: John Thiessen moved to approve food prices as presented. Travis Day seconded the motion. Vote: 6-0.

Student/Parent Handbook 23/24

Discussion took place among the board regarding the updated cell phone policies and other policies for 23/24. Dr. Steggall explained that Ed Counsel handles our handbooks and policies. She stated there would be follow up with any changes if needed.

ACTION IV: John Thiessen moved to approve the Student/Parent Handbook as presented with any future clarifications and updates. Danny Parra seconded the motion. Vote: 6-0.

Curriculum Handbook 23/24

Dr. Steggall stated that the handbook had been created through SMCAA last year. She stated that nothing changed from last year to this year except one line about uploading the curriculum and an assessment schedule.

Professional Development Plan 23/24

Dr. Steggall stated that the PD plan is similar to the prior one with the updated strategic plan and removal of a few documents not used now.
