# Tax Levy Hearing

# Proposed Tax Rate, Valuations and Estimated Revenue for the 2022/2023 School Year

Dr. Steggall reviewed the history of Assessed Valuation, current real estate and personal property as well as new construction. She stated no adjustments to the levy and things were staying steady. Dr. Steggall recommended setting the operating levy at \$3.9134 and debt service at \$1.00 for a total of \$4.9134.

## Community Donation

## 2022/2023 Budget

Dr. Steggall stated that the budget information was included in the Board packet and also presented 2 powerpoint slides. She reviewed that ending year projection is 17% in reserves but feels the district will come in better than that, possibly around 22%.

ACTION V: John Thiessen moved that the budget be approved as presented. Greg Harris seconded the motion. Vote: 7-0.

## Start of School Undates

Dr. Steggall reviewed enrollment at all levels. She stated that Ellis had 19 new students with 17 transferring out; Middle School had 11 new students with 4 transferring out; and the High School had 7 new students with 5 transferring out. Dr. Steggall mentioned that we now have a new transportation Director, Catherine Bouleware, Bill Terry had retired. Catherine assured Dr. Steggall that they are ready to transport kids and has 2 drivers completing CDL classes that will be joining the team as well very soon.
